INTRODUCTION

valenciaportpcs.net is a technological platform created by Port Authority of Valencia (PAV) providing services designed to streamline and facilitate the operating processes of companies of the port community. The platform manifests yet another step forward of our commitment to bolster the competitiveness of such companies.

Efficient information management is a key factor of the competitiveness of any company involved in transportation due to the vast quantities of information created and interchanged.

Through this platform Valenciaport provides logistics agents with a new instrument for them to offer their customers a better service, helping them thereby to become more competitive whilst allowing them to capture and increase cargo loyalty thanks to improvements in the following areas: Efficiency, Connectivity, Integration and Modernization.

valenciaportpcs.net Services

The PAV commercializes the use of the valenciaportpcs.net platform among members of the Port Community of Valenciaport.

According to current legislation, for commercial service tariffs must be established to cover the costs incurred by the PAV to provide the service.

valenciaportpcs.net offers nine transactional services, in addition to other horizontal monitoring and research which are available to all users of the transactional services. Furthermore, we have defined new tariffs for value-added services different from transactional.

Description of services

1. **Bookings.** Complete and consolidated cargo from / to any port. Through our connection with INTTRA and GTNexus allows freight forwarders send booking request with major ocean carriers. Direct connections with carriers for the reception of Bookings
2. **Shipping Instructions.** Complete and consolidated cargo from / to any port. Allows users of valenciaportpcs.net to automatically carry out the documentary processes to compile cargo manifests and create bills of lading (B/Ls) with major ocean carriers.
3. **Inland Transport.** Allows agents involved in the realization of land transport the generation and management of transport orders, release and admission orders necessary for carrying out the transport of goods within the port areas and the release and admission confirmations from container terminals and / or container depots.
4. **Railway Transport.** Allows agents involved in the realization of rail transport the generation and management of transport orders, release and admission orders necessary for carrying out of rail transport of goods within the port areas and the release and admission confirmations of container rail terminals and port and railway. It also allows the sending of lists of loading and unloading to the station and port and railway terminals, as well as get them further confirmation of the loading and unloading of containers contained in those lists.
5. **Port Call Management.** Allows port call and mooring authorization requests to be processed directly with the Port Authority of Valencia (PAV) and the Harbormaster's office as well as for the corresponding authorizations for these requests to be received directly. The comprehensive form made available makes it possible to complete rapidly a request, transmitting it automatically in one go to the PAV, the Harbormaster's office and Customs.
The Port Call Management service makes it possible to send to the National Single Window: Vessel notifications including technical details of vessels, Passenger notifications, Waste notifications.
6. **Dangerous Goods Management.** Allows shipping agents to present authorization requests directly to the Port Authority of Valencia (PAV) and the Harbormaster's office for the loading, discharging and transit of dangerous goods in the ports managed by the PAV. The service also serves to present the respective notifications required for dangerous goods remaining in vessels during port calls at the ports managed by the PAV.
7. **Goods Declaration.** Allows shipping agents to present import and export cargo manifests directly to the Port Authority of Valencia (PAV) and the Spanish State Tax Agency as well as to amend such documents when needed pursuant to established procedures.

8. **Instructions to Terminals (List Orders)**, Permits shipping agents to send the vessel loading and discharge lists to the container terminals and obtain the respective confirmations of the loading and discharge of the containers figuring on these lists from the terminals.
9. **Automatic Customs Check for Import, Export and transshipments**. Paperless Import Customs Clearance and Paperless fully automatic container export and transshipment Customs control.
10. **Customs Information and Customs Status Data**, Provides shipping agents with information on the customs clearance of containers and the consignments declared in the cargo manifests to be cleared by the customs office.
11. **Track & Trace**, This service allows users of the platform to obtain information to track and trace their shipments such as the current status of their cargo, transshipments carried out and/or documents processed. The platform also enables users to integrate this information into their systems to present it to their customers.
12. **Schedules**. A single source of information on the departures and arrivals of vessels of the world's major ocean carriers at the ports managed by Valenciaport. Provides information on the offer of maritime transport services (contact information, date of publication, service name, vessel name and voyage number of ships that are part of the planned service and covering ports and dates of scale provided in each).
13. **Particular integration**. It applies to all companies that require, from the time of application of these tariffs, send or receive a message different of the standard of the platform.
14. **Instant notification**. Applies to companies that make mass mailings of instant notification of messages.
15. **Integration with third parties**. This tariff applies when a user of valenciaportpcs.net exchanges messages to / from points other than the users of the platform, always with permission from the PAV.
16. **Administrative Management**. It applies to all companies that do not receive the electronic transmission of invoices and do not have direct debit for the payment of fees.

COMMERCIAL PROMOTIONS

All the companies will be charged at the start with the most economical category for its profile (excluding Mini Rate, except those users that justify a traffic implying a Mini)

At the end of this period the user category shall be calculated based on actual data that exists in the system for each user, for that is extrapolated usage data to one year during that period.

TARIFF MODEL OF VALENCIAPORTPCS.NET

In an effort to address the reality of the business of the companies using valenciaportpcs.net and in compliance with the requirements of the RDL 2/2011 of September 5, the following tariff model is approved:

- A different rate depending on the main professional profile of the user company is established. These profiles are:
 - Shipping Agent.

- Freight Forwarder, Customs Broker, or Logistics Operator.
 - Land or Rail Operator Carrier.
 - Containers depot.
 - Port or Interior terminals.

- Tariff levels are set (flat rate) for each profile, whose amount depends on the activity of the company in the platform. In those profiles where necessary has been defined rate "mini" without fixed cost and payment transaction, aimed at users with less traffic.
 - For each user company profile, with the rate assigned by the level of movements, all transactional platform services that correspond to their profile are included..
 - For the shipping agent profile special tariff cases are listed, for those who only use the port services (Calls, dangerous goods and summary declarations) and for those who only use the service summary declarations and cargo manifests.
 - For profiles of Agent Marine and Terminal, when measuring the traffic to calculate the corresponding tariff the full TEUs of import and export will be counted, but not the transshipment and empty. For the Freight Forwarder is measured by total TEUs. For Truck Companies and Container Depot is measured by Orders (Containers).
 - The calculation of the movements of each user in order to calculate tariffs will be done on the last twelve months of application of the tariff in the time of billing. Users will be reclassified every three months, using as a basis the actual data in your system on each, and extrapolating data to one year for those whose time of use of the platform is less than one year.
 - Billing is done on a quarterly basis taking into account usage data contained in the system for each user for the period.
 - The starting tariff is unique per company.
